At GFX (GFX International Co. Ltd.), we are committed to protecting the privacy and security of our clients' personal information. This Privacy Policy outlines how we collect, use, disclose, and safeguard the information provided to us by our clients. By accessing or using our services, you agree to the terms outlined in this Privacy Policy.

Information We Collect
